Objetivo:

Eligibility:

Applicants must:

- Be a graduate student or early career researcher (no more than 10 years postdoctoral)
- Be affiliated with nonprofit charitable, educational, and scientific institutions, or governmental entities operating exclusively for charitable and educational purposes
- Have a demonstrated knowledge of anxiety and anxiety research, either basic or clinical
- Have demonstrated competence and capacity to execute the proposed work

Funding:

1 grant of USD \$8,500

- Be affiliated with a nonprofit charitable, educational, or scientific institution, or governmental entity operating exclusively for charitable and educational purposes
- Have demonstrated competence and capacity to execute the proposed work

1 grant of USD \$21,500

Call for proposals: Connecting Indigenous Research and Leadership in Canada and the Global South

Objective:

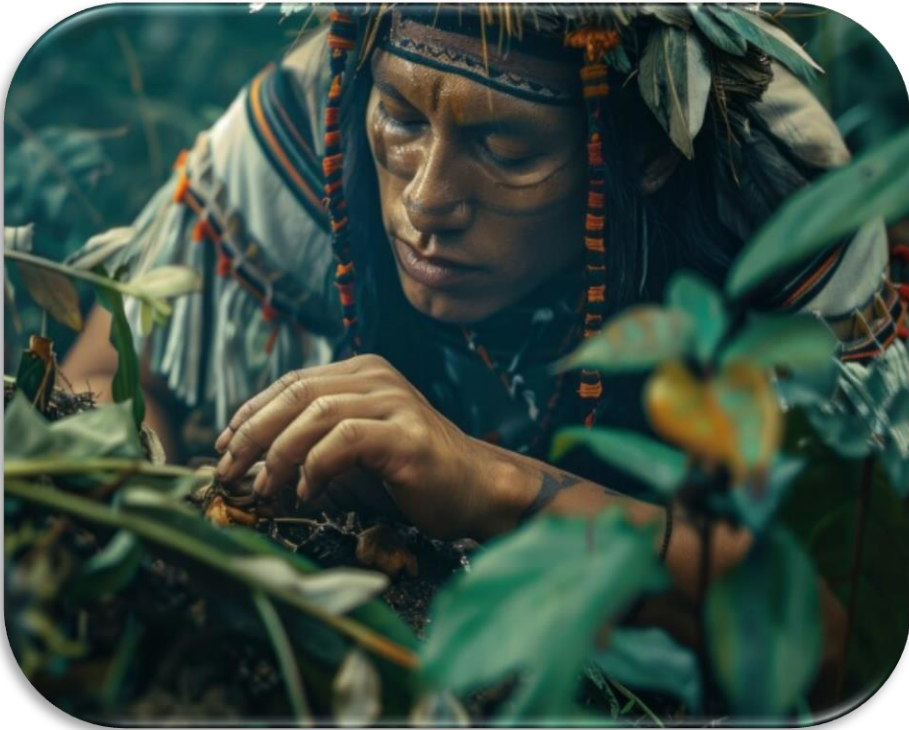
To connect Indigenous research and leadership in Canada with those in the Global South, complementing the SSHRC-led initiative. The aim is to co-develop an interdisciplinary, Indigenous research agenda and build alliances between Indigenous researchers in the Global South and First Nations, Métis, and Inuit researchers in Canada. Activities should facilitate knowledge-sharing and potentially lead to broader joint research endeavors in the future.

Eligibility:

Non-profit organizations based in the Global South that work with or represent Indigenous peoples and support Indigenous-led research. Must collaborate with a Canadian Indigenous organization (First Nations, Métis, or Inuit).

Funding:

Up to seven grants of up to 100,000 Canadian dollars will be awarded. The project duration is one year, including all research activities and the final report.

ARVO Foundation Collaborative Research Fellowship

Objective:

This Fellowship is intended to promote international scientific interactions and innovative research. This fellowship pairs researchers from developing countries with established scientists to strengthen ophthalmic research capacities. It supports a one-year project, which can include additional training in specialty equipment or research methodologies.

Eligibility:

Eligible applicants are researchers from developing countries with collaborative eye research projects (new or up to one year old). They must have completed their terminal degree (PhD, MD, or equivalent) in the past 10 years, not have been fellows at the collaborator's institution, and the collaborator must be a current ARVO member. Each collaborator can join only one fellowship per year. ARVO officers, board, and committee members are not eligible.

Funding:

Three fellowships of up to USD \$10,000 each will be awarded

Robert Wood Johnson Foundation issues call for proposals for Reinvesting in Racial and Indigenous Health Equity Research

Objective :

The purpose of this call for proposals (CFP) is to meet the current moment by supporting timely, actionable health equity research that has been interrupted by shifts in federal funding. We will award up to \$5 million for Rapid Response Research grants to help at least partially offset federal funding losses to existing research.

Eligibility :

Applicants must be organizations based in the United States or its territories, though teams may include international members. Eligible projects must focus on U.S. health equity and have lost prior federal funding. Priority is given to early- to midcareer antiracist or anticolonial researchers. Biomedical or clinical projects, and project directors receiving more than 50% of their salary from another RWJF grant, are not eligible.

Funding :

Funding ranges from USD \$50,000 to USD \$200,000 for up to 24 months. Eligible costs include staff salaries, community partners, incentives, consultants, data collection, analysis, travel, dissemination, and indirect costs. Funds cannot be used for clinical trials, construction, or political activities

NAS Prize in Food and Agriculture Sciences

Description:

The NAS Prize in Food and Agriculture Sciences recognizes research by a mid-career scientist (defined as up to 20 years since completion of PhD) at a U.S. institution who has made an extraordinary contribution to agriculture or to the understanding of the biology of a species fundamentally important to agriculture or food production. For the purpose of the prize, areas of science with applications to agriculture include plant and animal sciences, microbiology, nutrition and food science, soil science, entomology, veterinary medicine, and agricultural economics..

Eligibility:

Eligible candidates are mid-career scientists (within 20 years of their Ph.D.) who have made outstanding contributions to agriculture or the biology of key food-producing species.

Funding:

The award consists of a cash prize of USD \$100,000

NEI Research Grant for Vision-Related Secondary Data Analysis

Objective:

The purpose of this Notice of Funding Opportunity (NOFO) is to conduct secondary data analyses using existing data collected from humans participating in vision-related clinical trials, epidemiologic, and other clinical research studies or represented in clinical and health care database resources (e.g., electronic health records).

Eligibility:

Eligible applicants include universities, nonprofits, for-profits, governments, tribal entities, and foreign organizations. All required registrations (SAM, UEI, eRA Commons, Grants.gov) must be completed before applying. Any qualified individual can be PD/PI; multiple distinct applications allowed, no cost sharing required.

Indicative budget:

Permits direct costs up to USD \$275,000 for the entire two-year project period, plus applicable F&A for consortia. No more than USD \$200,000 in direct costs may be requested in any single year.

We award the Grants to individuals affiliated with institutions abroad with challenging and innovative research projects of top academic quality through a highly competitive, strictly merit-based selection process. The all-important selection criteria are the academic excellence of both the applicant and the cooperative project — reflected, for example, in high-ranking publications — as well as the potential for networking with the University of Bayreuth beyond the local host.
